DECLARATION TENDER OF UNCLAIMED GOODS

1.Subject

ThPA S.A. announces a call for a bidding auction for the sale of unclaimed goods, according to the Regulation for the declaration and sale of unclaimed goods of ThPA S.A (Decision BoD 6838/14.10.2016, Vol. Gazette B'4079/20.12.2016) and the terms of the hereby declaration. The unclaimed goods are described in the attached Annex 1 which is an integral part of it.

2.Participation Right

In the bidding auction for the sale of unclaimed goods, can participate any natural or legal person, apart from the staff of ThPA S.A. with any employment relationship.

3.Place & Time of Participation

The bidding auction will take place, with physical presence in the event hall (meeting room), on the ground floor of the headquarters of ThPA S.A. (Pier 1) within the port of Thessaloniki on **Tuesday 21/05/2024 at 11:00 a.m.** and if necessary, may be repeated on **Tuesday 28/05/2024** or/and **Tuesday 04/06/2024** at the same time and location.

4.Participation method-Bidding auction

The offers shall be submitted in written sealed to the committee on the day of the auction from 10:00 a.m. to 11:00 a.m.

Tenders should have as a minimum the details of the participant, description of the cargo, container number, unclaimed protocol number and the price offered.

The written and sealed tenders for the relative unclaimed protocol order number, **must not contain a clause or a condition**, they have to be irrevocable and must be signed and/or bear the stamp of the participant, otherwise, they shall be deemed void. At the opening of the auction, the committee shall record in its minutes the identity of the participants who have already submitted their bids and guarantees. The committee shall declare the procedure for the collection of tenders closed at 11.00 a.m. and shall immediately thereafter open the tenders publicly by recording their contents in its minutes. The announcement of the bidder for each auctioned container shall be made in accordance with the number of the unclaimed goods protocol. If only one written bid is submitted, the auctioned goods are awarded to the sole bidder. If two or more written bids are submitted, the auction shall

continue through verbal bidding only between the two bidders who offered the highest price with the written bids. In the event that: a) two or more bidders submit written bids with the same highest price, the oral bidding process continues between them, b) the written bid with the highest price is one, and two or more bidders submit equal written bids with the immediately lower price, these bidders also participate in the oral bidding process. Oral bids are submitted immediately thereafter to the committee. The award is made to the bidder who offers the highest price, after first being invited three times for a higher verbal offer. If there is no verbal bid, the auctioned goods are awarded to whoever submitted the highest written bid. In the event of a tie for the highest written bid without a verbal bid being submitted, the auctioneer shall immediately conduct a drawing of lots, from which the highest bidder shall be selected.

5. Participation Documents

To participate in the bidding auction and to verify the identity of the participants, the following documents must be submitted with the written tender by all participants:

- Identity card or passport (copy and original),
- a Notice of Tax Assessment or a VAT Registration Certificate for the immediately preceding year,
- Certified Authorisations,
- Certified Solemn Declarations,
- Certified articles of association or a document showing the constitution and legal representation,
- Any other document that may be deemed necessary,
- Guarantee for participation,
- Information on the processing of personal data, signed by the participant in the case of a natural person or by the legal representative of the participant in the case of a legal person.

6. Guarantee for participation

A prerequisite for the right to participate in the open tender-procedure of the auction of unclaimed goods of ThPA S.A. is the provision of a Participation Guarantee, in the amount of one thousand (1.000€) euros and duration of at least thirty (30) days from the date of the auction. The Letter of Guarantee must be issued by a reputable and recognized Monetary Financial Institution (MFI) operating legally in Greece.

Instead of submitting a Letter of Guarantee, the Participant may deposit the amount as a cash pledge or cash collateral in the following Bank Accounts maintained by ThPA S.A., prior to the start of the auction procedure.

In all cases, the relevant document shall be submitted to the Auction Committee. The amount of the guarantee shall be returned at the end of the auction to all participants except the highest bidder. In case of award, the warranty letter of the bidder shall be returned upon delivery of the goods, while, in case the amount is deposited, it may be deducted from the auction price. Any offers without the appropriate Participation Guarantee will be rejected as unacceptable.

7. Obligations of the participant-highest bidder:

- The bidder, to the name of whom the auction was awarded signs the **deed of sale** and must deposit immediately after the end of the auction, an amount equal to at least **twenty-five percent (25%) of his bid which will also be valid as guarantee**, or the whole amount thereof,
- The natural or legal entity, to the name of whom the auction was awarded, shall be obliged within five (05) working days from the receipt of the award decision to pay any remaining amount of auction proceeds as well as the publication costs of the tender, **otherwise, the guarantee paid based on the previous paragraph is automatically forfeited in favor of ThPA S.A.**,
- The natural or legal entity, to the name of whom the auction was awarded is obliged to pay the rights due to ThPA. S.A. from the day of notification of the award decision of the tender until the day of receipt of the goods, in accordance with the current tariff book of ThPA S.A.,
- The auctioned unclaimed goods must be received within ten (10) days from the receipt of the award decision, otherwise the paid auction price is forfeited in favor of ThPA S.A.,
- The goods to be auctioned which are subject to customs duties, taxes, fees and rights of the Hellenic State are delivered to the bidder if he submits to the competent department, the completed original relevant customs documents, in accordance with the applicable provisions,
- The costs for the publication of the tender shall be paid by the beneficiaries of the goods in proportion which are specifically calculated at a rate of ten percent (10%) on the bidder's offer, for up to 300 euros and at a rate of four percent (4%) for a bid over 300 euros, and up to a maximum of 60 euros.
- ThPA S.A. shall assume no responsibility regarding the legal and actual condition (quality or any other condition) of the sold goods which the interested party shall examine, only

visually, at their storage spaces, in the Container Terminal within the port of Thessaloniki before the day of the auction in the presence of ThPA's representatives. ThPA S.A. shall assume no responsibility for any inaccurate description of the type and the qualities of goods. Unclaimed goods will be sold in the condition they are in at the time of sale in the warehouse.

- The participant in the auction bears the exclusive responsibility and liability, he has no right to compensation or any other right other than those set out herein. The participation in the auction implies his full acceptance of its conditions and terms.
- During his visits and stay to the premises of ThPA S.A. , the participant must comply with the Regulations of ThPA S.A. , as posted on the official corporate website (www.thpa.gr),
- The participant bears the exclusive liability, civil and criminal, for any kind of damage, loss or damage to the property of ThPA S.A., his staff, or a third party, due to the actions or omissions of his staff, as well as the exclusive liability, civil and criminal, for any injury or death to his staff, to the staff of ThPA S.A. , as well as to any third person, during his and/or his staff's visits to the premises of ThPA S.A.
- The participant is obliged to comply with the terms and restrictions applied to ThPA S.A. by the Concession Agreement of 02.02.2018 between the Hellenic State and ThPA S.A., already ratified by Law 4522, Government Gazette 39 A'/07.03.2018, and as in force from time to time, of which he is aware.

8. Postpone, cancel, repetition of the procedure or modification of the schedule.

ThPA S.A. reserves the right to postpone or cancel the auction or modify the timetable of its completion or repeat it at its total discretion, without engaging any responsibility towards the participants.

9. Demonstration of the auctioned goods

ANNEX 2: INFORMATION DOCUMENT FOR THE PROCESSING OF PERSONAL DATA

UPDATE ON THE PROCESSING OF PERSONAL DATA, pursuant to Article 13 of the GDPR 679/2016
(accompanies the **Application Forms** in Tenders-Calls-Offers etc. of the Procurement and Investment Division of "ThPA SA").

The Société Anonyme under the name "Thessaloniki Port Authority S.A." and the distinctive title "ThPA SA", having its registered office in the Municipality of Thessaloniki (within the Port, Pier 1, PC: 54625, tel.: 2310 593 118- 121), as legally represented by Mr. Arie Koppelaar, Chief Executive Officer, hereby **informs** and, in conformity with the provisions of the applicable legislation on the protection of personal data, and, the General Regulation EU 679/2016 in particular, **in its capacity as a "Data Controller"**, the natural person (*hereinafter the "Data Subject"*), who signs the Application Form, the Offer or other similar form of the Procurement and Investment Division of "ThPA SA" and submits the necessary supporting documents, **either** on its behalf, as a representative of a private company **or** as a natural person -legal representative of the participant in the legal person procedure, **or** in another similar legitimizing capacity, that ThPA SA and its competent Services-Divisions-Departments (*such as its employees, acting under its supervision, by order and on its behalf and within the framework of their powers and, possibly with others, jointly referred to as "Controllers" and "Processors", third parties or recipients: other participants in the procedure, Ministries, public authorities, Tax Offices, Judicial Authorities etc. based on the compliance with the legal obligation of the "Processor" or in fulfilment of his duty or for performance of a contract*), **collects, processes and retains** the personal data included in the Application Form, Offer or any other document of the Procurement and Investment Division of "ThPA SA" and in its accompanying documents, which are voluntarily submitted to "ThPA SA" by the "Data Subject" either on his behalf (*private company*) or on behalf of the legal person representing it.

This data will be used for the purposes of handling the Application Form, the Offer or any other similar document of the Procurement and Investment Division of "ThPA SA". The purpose of processing may be: The evaluation of the Application/Offer etc., the verification of the details of the «Data Subject» or the company that it represents, required by the procedure, the evaluation of the suitability of the «Data Subject» or the company it represents, as a candidate counterparty towards the conclusion of a contract with "ThPA SA" or with a view to concluding a contract (Article 6, par.1b GDPR Expl.44). Furthermore, "ThPA SA" processes such data in order to communicate with the "Data Subject" whenever it considers it to be necessary, on issues relating to the procedure and for reconciling "ThPA SA" with the requirements of the Regulation and law (*compliance with his legal obligation, Article 6, par 1c GDPR*). This data is kept at the competent Procurement Department for **as long as it is necessary to check the Application/Offer etc. and the data submitted therein, throughout the period needed to complete the procedure, throughout the period of submission of any objections and lodging an appeal that may be provided for internally or by law, throughout the period of fulfilment of both parties' obligations and the period of limitation for bringing claims and, generally, for as long as it is required from the letter and the spirit of the Subcontracting and Procurement Regulation and the relevant law and contracts governing the operation of ThPA SA, as applicable.** Then, they are filed, either on paper or electronically in such a way that access is not authorized to non-authorized employees. After the elapse of the necessary time period, they will be safely destroyed, as provided for by the relevant legislation (*the provisions of Article 191 §2 of Law 4610/2019 (A'70) apply for the period up to 23- 3- 2018, while, the maximum limitation period laid down in the Civil Code shall apply from then on and for the conversion of the Processor into a SA*). The provision of such data is necessary for this procedure and, failure of the "Data Subject" to provide them will lead to the inability of the Data Subject to participate in the procedure and the impossibility of providing such service.

The "Data Subject" can submit a request to the "Data Controller" on: Access-information, correction, limitation of the processing of data regarding it, objection to processing, erasure of data and data portability **subject to the conditions and limits laid down by the applicable legislation** (*e.g. 17 par.3, 20 par.3, 23 GDPR*). These rights are exercised either by filling in the relevant application form available **on the Protocol and the Investment and Procurement Division** of "ThPA SA", or by sending a letter to the address: "ThPA SA", Pier 1, within the port, PC: 546, Thessaloniki, tel: 2310 593118-121, or by sending an email to the address: dpo@thpa.gr. The "Data Controller" provides to the "Data Subjects" will all relevant information on the action taken upon request, pursuant to Articles 15 to 22 of the GDPR without delay and in any case **within one month** from receipt of the request. This deadline may be extended by a further period of two months, if necessary, taking into account the complexity of the request and the number of requests (*see for more details: article 12 par. 3 of the GDPR*). Also, for any complaint, the "Data Subject" has the right to notify the **Data Protection Authority** either in writing (address: *Kifisias 1 - 3, P.C. 115 23, Athens*) or via email (www.dpa.gr).
