SECTION A: PRICE LIST – DEFINITIONS & CONDITIONS

The present Tariff Book defines the charges payable to THPA for the provision of services and the use of facilities at the Port of Thessaloniki for car parking areas.

1. DEFINITIONS

Customer: any person or entity requesting, receiving, or benefiting from the provision of services/facilities by THPA.

Concession Agreement: The Concession Agreement between the Hellenic Republic and Thessaloniki Port Authority Société Anonyme regarding the use and exploitation of certain areas and assets within the Port of Thessaloniki (G.G. Issue 39A/07.03.2018 – Law 4522/2018)

Port Land Zone: as defined in Concession Agreement.

2. APPLICATION

The rates to be charged by THPA to its Customers for the provision of its Services and/or for the use of its facilities, are categorized as follows:

TARIFF I: CAR PARKING AREAS

3. GENERAL

3.1 All the charges set in the various Tariff Schedules include V.A.T. unless otherwise specified.

3.2 The original text is in Greek and English and in the event of any discrepancy or inconsistency between the Greek and the English version, the Greek version shall prevail over the English one.

2.2 MONTHLY CHARGE

3. GENERAL

- Every parking hour is charged based on the price list in force at the hour of the day that the service is provided.
- Any fraction of one hour that is less than fifteen (15) minutes will not be charged.
- Occupying two parking spaces is charged double and so on.
- Parking in the traffic lanes is charged three times.
- The vehicle must leave the parking area not later than fifteen (15) minutes after the payment of the parking fee.
- Monthly or annual card loss/wear: **€10,00**
