Box 10467, P.C. 54625, tel. 2310 593 118-121, fax 2310 510 500, email: <a href="mailto:secretariat@thpa.qr">secretariat@thpa.qr</a>, <a href="mailto:www.thpa.qr">www.thpa.qr</a>) and TIN 099356700 of the Tax Office of Thessaloniki, hereby informs, and in accordance with the provisions of the applicable legislation on the protection of personal data, and in particular the General Reg. 679/2016 EU and Law 4624/2019, that, as "CONTROLLER", he collects, maintains and processes your personal data indicated in the front application and the accompanying forms, that the Applicant "Data Subject" voluntarily submits to "ThPA S.A." in order to satisfy his request. The data is used for the need of processing the application. The purpose of the collection and processing is the need to respond to the Application, the need to communicate with the Applicant-"Subject", the need to perform and fulfill the relevant service provided by "ThPA S.A." and perform the contract you conclude with "ThPA S.A.". In case you refuse to provide us with this information, you may not be allowed to enter the parking lot of "ThPA S.A." and/or our respective service to you may not be possible.
- **2. Legal processing base:** The processing takes place on the basis of **our legitimate interest** and **our compliance with our rights and obligations**, pursuant to Law (6.1f' and 6.1c' Gen. Reg. 679/2016 EU, Law 3622/2007, Law 4150/2013, ISPS/IMO Code and other legislation, as applicable). Moreover, to conduct commercial, administrative, financial, accounting procedures, in accordance with our statutory purposes, and to perform the contract between us (6.1b Gen. Reg. 679/2016 EE).
- **3. How to collect data:** Your data is collected at the time you submit the front Application and is confirmed when you cross the Entrance Gate of the parking area of "ThPA S.A.". They are kept in the competent Department (*Security Department*) for the legally prescribed period (*5 years*) and are destroyed safely after the end of this retention time. In the event of illegal activities or in other cases, provided for by the legislation, your data may be retained longer, up to the maximum limitation period of our company's claims.
- **4. Lawful use:** During the use of parking services in the parking area of "ThPA SA", you are required to comply with the Highway Code, which also applies in this area.
- **5.** Access to your data: Your personal data is accessible by the Company's Security Department (<u>security@thpa.gr</u>, tel. 2310 593 370). It may be communicated to the competent police, judicial and public prosecutor authorities.
- **6.
