

## Subject: 2<sup>nd</sup> document of Clarifications for tender 005/2023 for the disposal of old equipment of OLTH S.A.\*

\*Questions are answered below on this background and style.

1. Paragraph 3.2 – is the technical report you refer to the method statement for stripping? - you want a lifting plan to be included.

The specific requirement concerns categories 1 and 2. As long as you do not participate in those, it is not considered necessary to submit a method of disengagement. Paragraph 3.2 concerns the documentation of technical ability, which is an evaluation criterion. This specific is an evaluation and not a rejection point from the competition.

- Paragraph 3.2 should the Risk Assessment Study and countermeasures be included in the Method Statement? Do you also want a Health and Safety Plan?
   The specific requirement concerns categories 1 and 2. As long as you do not participate in those, it is not considered necessary to submit a method of disengagement. Paragraph 3.2 concerns the documentation of technical ability, which is an evaluation criterion. This specific is an evaluation and not a rejection point from the competition.
- Part A-paragraph 3.2-5th point- regarding the pressure exerted by your feet is a technician's certificate sufficient or do you need some other document?
   The specific requirement concerns categories 1 and 2. As long as you do not participate in those, it is not considered necessary to submit a method of disengagement. Paragraph 3.2 concerns the documentation of technical ability, which is an evaluation criterion. This specific is an evaluation and not a rejection point from the competition.
- 4. For category 1 cranes I will need the full details (height, width and weight) to be able to see what crane will be needed.

You should study and analyze published plans.

 Do you want the technical report, the lifting plan (if needed) and the risk study in the file submission phase or only by the contractor? The technicians who will be compiling the reports told us that it is impossible to have them ready by 10/10.
 The point concerns the documentation of technical ability, which is an evaluation criterion. This

point is an evaluation point and not a rejection point from the competition.

6. We need some additional information for the removal of the following equipment: A' GERANOBRIDGES In our opinion the safest way of disassembly is the reverse assembly process (we refer to the above sections). So we need: A) the maximum height B) the height of the boom C) the weight of the boom / overall or its parts (parts joined by fire are visible) D) the length of the boom B' Electric cranes 10tn & 27tn 1) Maximum height 2) Weight of the upper part (rotation and upper part) This information is necessary to prepare the Technical Offer.

- In category 3A, separate price only for copper cables. If there are aluminum cables or other material price together with the transformers. Category 3A Electrical miscellaneous (transformers and cables)
   Transformers (aluminum cables etc.) price A Copper cables price B
   The category will be common for transformers and cables. The price will refer to both (2) mentioned materials.
- 8. In the model of the financial offer, category 3 is divided into 3A, 3B and 3C. which materials belong to each subcategory? For each subcategory do you want a separate value as the table is structured or one value for the whole category 3?

## We expect prices in categories 3A, 3B and 3C as mentioned.

9. We are only interested in the scrap and the cables, do we need to have all the permits (Engineering, AEPO, schedule, technical report, Risk assessment, etc.)?



The specific requirement concerns categories 1 and 2. As long as you do not participate in those, it is not considered necessary to submit a method of disengagement. Paragraph 3.2 concerns the documentation of technical ability, which is an evaluation criterion. This specific is an evaluation and not a rejection point from the competition.

10. Do the responsible declarations referred to in paragraph 3.1 (apart from those referred to the mechanical engineer) need to be issued only by the Managing Director or by all the natural persons representing the company?

11. According to point 3.1 JUSTIFICATIONS FOR PARTICIPATION, a responsible statement is issued for the knowledge obtained by the company and the mechanical engineer regarding the conditions of the competition. So there is no need for any additional supporting document for Part A' /1.1: Suitability to practice professional activity?

## You need to send the Responsible Declaration.

12. In 1.2 TECHNICAL AND PROFESSIONAL CAPACITY, the license for the Management-Collection & Transport of non-hazardous waste is requested. The specific license has now been abolished in previous years.
